Antigua and Barbuda Visitor Arrivals Quarterly Report: Jul-Sep 2017



Foreword

This report provides a quantitative analysis of Visitor Arrivals to Antigua and Barbuda for the Second Quarter of the year 2017. Data for this report was provided by the **Immigration** Department from the Embarkation/Disembarkation (E/D) cards and the Cruise Ships' manifests. This report was prepared and published by the Research and Statistics Department in the Ministry of Tourism, Economic Development, Investment & Energy, in collaboration with the Statistics Division within the Ministry of Finance & Corporate Governance.

Classification

Visitors are classified as persons who stay more than 24 hours, but less than one year, within a country outside of their usual country of residence. Persons who are in transit and/or spend less than a day are not classified as visitors. Total Sea Arrivals are comprised of tourists arriving by Cruise and Yacht, with Cruise visitors spending less than a day, and Yacht visitors a day or more.

Introduction

This overview represents the visitor arrivals to Antigua & Barbuda for the Third Quarter (QTR3) of the year 2017. Table I below displays a decrease of -11 % in Air Arrivals when compared to arrivals by air for the previous year 2016. The table also shows there was a decrease in Sea Arrivals by 25% when compared to the total sea arrivals for the last quarter of 2016. Following the final data analysis, during the third quarter of 2017, there was an overall decrease in visitor arrivals by -16%.

For the 3rd quarter of 2017, Air Arrivals accounted for 71% of the total passenger arrivals while in 2016 accounted for 67% of passenger arrivals.

Arrivals by Air

The Third Quarter of 2017 recorded 48,354 visitor arrivals by Air to Antigua & Barbuda, -11% less than the same period for the previous year of 2016. For the period 2013-2017, 2016 shows the highest percentage of growth increase of 9% over the 5-year period. Figure 1 below also shows that in 2013 and 2015 there were slight growth increases with 4% and 1% respectively while there was a decrease in air arrivals by -5% in 2014.

Arrivals by Sea

Table 2 below represents the number of visitor arrivals by sea for the third quarter of 2017, categorized by vessels, Table 2 shows a decrease in the number of cruise passengers by -22% from QTR3 2016 to QTR3 2017. Cruise calls increased by 1% with a total of 9 cruise vessels when compared to 8 for the same period in 2016, additionally yacht passenger arrivals saw an increase of 18% from the previous year of 2016. Yacht calls also increased by 15% with a total of 229 calls compared to 200 for that period of the previous year.

When the combined data for sea arrivals was analyzed over a period of 5 years from 2013-2017 for the third quarter of the year, visitor arrivals by sea experienced growth between 2013-2015 then a constant decline in passenger arrivals by -36% and -25% in 2016 & 2017 respectively.

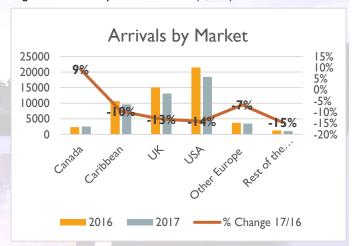
Figure 2: Sea Arrivals (QTR3) 2013-2017



Arrivals by Market

Figure 3 compares visitor arrivals by major source markets for the period 2016/2017. The United States continues to show a decrease from Quarter 2 of 2017, even though it is still the leading source market. The United Kingdom and the Caribbean also experienced decreases in visitor arrivals of -13% and -10% respectively. Canada also saw a decrease of -10%.

Purpose of Visit

Figure 4: Purpose of Visit (QTR3) 2017

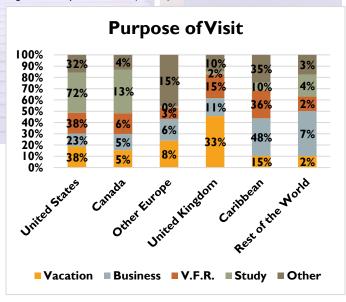
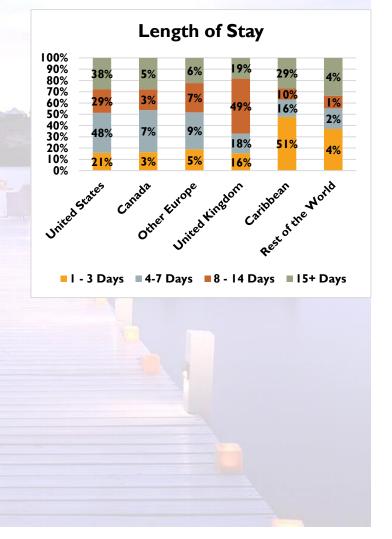


Figure 4 highlights the purpose of visit for visitors in the third quarter of 2017 (QTR3). Out of the total number of tourists who come for vacation, a greater percentage come from the United States (38%) and the United Kingdom (33%). This is followed by visiting friends and relatives, of which the United States and the Caribbean contribute 38% and 36% respectively. The United States and the Caribbean also accounted for the majority of visitors who indicated business as the main purpose of visit with 23% and 48% respectively. A large portion of visitors who came to Antigua to study came from the USA (72%) and the Caribbean (48%). The USA and the Caribbean significantly accounted for the number of individuals who indicated (other).

Length of Stay

Most visitors to the island stayed for a period of 4-7 days. The United States accounted for 48% of the tourists who came for this time period while the United Kingdom and the Caribbean accounted for 18% and 16% respectively for this time period. Of the number of tourist who come for 15 plus days, the United States and the Caribbean account for 38% and 29% respectively.
